The franchisee will operate a club-level sports restaurant under the trade name and service mark "Buffalo Wings & Rings."

The estimated initial investment required ranges from \$1,280,000 to \$2,412,000. If you are not currently operating one or more Buffalo Wings & Rings restaurants, this includes \$40,000 (if you sign a Franchise Agreement for a newly-constructed restaurant) that must be paid to the franchisor Buffalo Wings & Rings, LLC. If you are currently operating one or more Buffalo Wings & Rings restaurants, this includes \$30,000 that must be paid to the franchisor Buffalo Wings & Rings, LLC. If you are purchasing a restaurant that is currently in operation, this includes a \$25,000 transfer fee that must be paid to the franchisor Buffalo Wings & Rings, LLC. If you are purchasing a restaurant that is currently in operation, this includes a \$25,000 transfer fee that must be paid to the franchisor Buffalo Wings & Rings, LLC. These sums do not include the cost of acquiring or leasing the business location and may not include the full cost of acquiring an alcoholic beverage license or financing costs.

In addition to individual restaurant franchises, Buffalo Wings & Rings LLC offers Area Development Agreements ("ADAs").

ADAs grant you the right to develop three Franchised Restaurants within a specified territory according to a negotiated schedule. The development fee is \$70,000. The estimated initial investment required ranges from \$1,325,000 to \$2,462,000.
