As a franchisee, you will operate a real estate sales and brokerage business providing strong branding, operational efficiency, cost savings and innovative services for the consumer.

The initial franchise fee is \$18,500. The estimated initial investment for your franchised business, including the franchise fee, ranges from \$39,533 to \$78,217.

#### **RISK FACTORS:**

1. THE FRANCHISE AGREEMENT REQUIRES THAT MOST DISAGREEMENTS BE SUBMITTED TO ARBITRATION OR LITIGATION IN WYOMING. OUT OF STATE ARBITRATION OR LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO ARBITRATE OR LITIGATE WITH US IN WYOMING THAN IN YOUR HOME STATE.
