The total investment necessary to begin operation of a Buildingstars Technician Program franchise is \$2,195-\$8,295. This includes \$995 to \$1,295 that must be paid to the franchisor or affiliate. The total investment necessary to begin operation of a Buildingstars On-Site Manager Program franchise is \$7,700 – \$14,095. This includes \$5,700-\$6,995 that must be paid to franchisor or affiliate. The total investment necessary to begin operation of a Buildingstars Corporate Program franchise is \$39,600-\$52,390. This includes \$33,000 - \$39,000 that must be paid to franchisor or affiliate.
