We offer two levels of Bumper Man franchises, as a franchisee operator or as a certified technician. The Franchisee Operator will operate a Bumper Man bumper repair service that offers mobile automotive bumper repair services on site at the customer's place of business. The certified Bumper Man technician performs bumper repair services as the employee of a Franchisee Operator.

The total investment necessary to begin operation of a Bumper Man repair service ranges from \$63,275 to \$90,300. This includes \$50,000 that must be paid to the franchisor. The total investment necessary for certification as a Bumper Man technician ranges from \$38,275 to \$65,300. This includes \$25,000 which must be paid to the franchisor for the certified Bumper Man technician program.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, no governmental agency has verified the information contained in this document.

We may use the services of one or more franchise brokers or referral sources to assist us in selling our franchise. A franchise broker or referral source represents us, not you. We pay this person a fee for selling our franchise or referring you to us. You should be sure to do your own investigation of the franchise.
