The franchise offered in this disclosure document is for the operation of a single BUMPERDOC franchise business under the BUMPERDOC System. A franchisee will operate an automobile reconditioning center specializing in automobile bumper repair, paintless dent repair and body repair under our name. The total investment necessary to begin operation of a BUMPERDOC Franchise ranges from \$148,049 to \$265,799. This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make payment to, the franchisor or affiliate in connection with the proposed franchise sale.
