We are Business Incentive Solutions Advisory Group, a California corporation. We offer franchises to qualified individuals and entities to own and operate a Business Incentive Solutions franchise under our service marks, trade names, programs, and systems under the name "Business Incentive Solutions," (the "Marks"). Our franchisees operate a business providing business consulting services specializing in helping small business owners with profit recovery and smarter tax management under the Marks and the Business Incentive Solutions programs and systems (the "Method of Operation").

The total investment necessary to begin operation of a Business Incentive Solutions franchise is \$34,850 to \$70,300. This estimate is only approximate. This includes the \$20,000 Initial Franchise Fee.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale.
