Business Partner Marketing Coach franchises operate businesses that specialize in selling an assortment of advertising and marketing services and merchandise to businesses and the general public, including Internet web page and graphic design, specialty advertising and marketing merchandise, such as embroidered clothing, signs, banners, trade show displays and graphics and services to its customers ("<u>BP Business(es)</u>").

The total investment necessary to begin operation of a BP Business is between \$66,000 and \$74,250. This includes \$55510 that must be paid to the franchisor or its affiliates.

Franchisees may also choose to become an area developer ("<u>Area Developer</u>"), earning the right to establish and operate a certain number of BP Businesses in a specified area ("<u>Area Development Business</u>"). The total investment necessary to begin operation of an Area Development Business will depend on the number of BP Businesses to be opened. The total initial investment necessary to begin operation of a five (5) unit Area Development Business is between \$141,000 and \$149,250, which includes \$130,510 that must be paid to the franchisor or its affiliates. The total investment necessary to begin operation of a ten (10) unit Area Development Business is between \$216,000 and \$224,250, which includes \$205,510 that must be paid to the franchisor or its affiliates. The total investment necessary to begin operation of a 15 unit Area Development Business is between \$216,000 and \$224,250, which includes \$205,510 that must be paid to the franchisor or its affiliates. The total investment necessary to begin operation of a 15 unit Area Development Business is between \$216,000 and \$224,250, which includes \$205,510 that must be paid to the franchisor or its affiliates. OUT OF STATE MEDIATION, ARBITRATION OR LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO MEDIATE, ARBITRATE AND/OR LITIGATE WITH US IN CONNECTICUT THAN IN YOUR OWN STATE.

- 4. THE FRANCHISOR MAY ESTABLISH MAXIMUM, MINIMUM OR OTHER PRICING REQUIREMENTS TO THE FULLEST EXTENT ALLOWED BY LAW.
- 5. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.

We pay this person a fee for selling our franchise or referring you to us. You should be sure to do your own investigation of the franchise.
