The franchises described in this disclosure document are for the operation of a business called **BUTTERFLI ME STUDIO**. The total investment necessary to begin operation of a franchised Studio is \$218,500 to \$625,000. This includes \$25,000 that must be paid to the franchisor.

If You are an Area Developer, You are required to pay the franchisor a nonrefundable Development Fee equal to the Initial Franchise Fee for the first Required Studio plus \$10,000 for each additional Required Studio.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully.
