The total investment necessary to begin operation of a franchised Studio is \$238,500 to \$765,000. This includes \$25,000 that must be paid to the franchisor.

If You are an Area Developer, You are required to pay the franchisor a nonrefundable Development Fee equal to the Initial Franchise Fee for the first Required Studio plus \$10,000 for each additional Required Studio.
