We offer regional area representative rights for Cacao 70 (US), Inc., which owns a franchise system for cafes specializing in the sale of various flavors of chocolate fondue-dipped soft-serve ice cream, chocolate drinks and dessert items such as waffles, cakes, crepes, and chocolate pizzas, under the brand name “Cacao 70”.

The total investment necessary to begin operation of a Cacao 70 area representative is \$186,500 to \$911,500. This includes \$175,000 to \$875,000 that must be paid to the franchisor or affiliate.

This disclosure document summarizes certain provisions of your area representative agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

The terms of your contract will govern your franchise relationship. Don't rely on the disclosure document alone to understand your contract. Read all of your contract carefully. Show your contract and this disclosure document to an advisor, like a lawyer or an accountant.

Buying a franchise is a complex investment. The information in this disclosure document can help you make up your mind.
