The franchise offered is for quick-serve and full service restaurants and mobile food vending units operating under the name "Calexico®" offering tacos, burritos, tortas, quesadillas, side dishes and beverages on a dine-in, carry-out and catering basis. Mobile vending units (either a truck or cart) may not be established unless you have an existing restaurant to provide menu items for the mobile unit.

The total investment necessary to begin operation of a Calexico Taqueria quick-serve franchised business is \$170,600 to \$473,100. This includes \$30,000 that must be paid to the franchisor and/or its affiliate, as appropriate. The total investment necessary to begin operation of a Calexico full service franchised business is \$250,600 to \$867,600. This includes \$30,000 that must be paid to the franchisor and/or its affiliate. The total investment necessary to begin operation of a Calexico truck unit is \$96,200 to \$194,500. This includes \$30,000 that must be paid to the franchisor and/or its affiliate. The total investment necessary to begin operation of a Calexico cart unit is \$79,250 to \$104,700. This includes \$30,000 that must be paid to the franchisor and/or its affiliate.

We may sell rights to individuals or entities to develop a number of restaurants within a specified area. If you are a multi-unit operator, you will pay a development fee equal to 100% of the initial franchise fee for the first Restaurant to be developed, plus a deposit of 50% of the initial franchise fee for each additional Restaurant to be developed under the Multi-Unit Operator Agreement. The total investment necessary will vary based on the number of Restaurants to be developed.

We also offer to qualified individuals and entities the opportunity to become our Development Agent within a specific geographical area. A Development Agent will act as our agent in a specific territory, solicit new franchisees, assist existing franchisees, and conduct inspections of Restaurants in the territory, among other things. The total investment necessary to begin operation as a Development Agent is \$308,200 to \$1,879,700. This includes between \$50,000 and \$1,000,000 that must be paid to the franchisor, as appropriate. A Development Agent must also own at least one Restaurant and pay the related fees, which are included in the total investment.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive the disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no government agency has verified the information contained in this document.

- 1. THE FRANCHISE AGREEMENT, MULTI-UNIT OPERATOR AGREEMENT AND DEVELOPMENT AGENT AGREEMENT REQUIRE YOU TO RESOLVE DISPUTES WITH US BY ARBITRATION AND LITIGATION ONLY IN NEW YORK. OUT OF STATE ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST MORE TO ARBITRATE WITH US IN NEW YORK THAN IN YOUR OWN STATE.
- 2. THE FRANCHISE AGREEMENT, MULTI-UNIT OPERATOR AGREEMENT AND DEVELOPMENT AGENT AGREEMENT STATE THAT NEW YORK LAW GOVERNS THE AGREEMENTS, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
- 3. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
