You must comply with all laws that regulate commerce in general and the food service industry in particular. These laws include (i) federal, state, and local laws regulating health and sanitation, (ii) federal immigration laws, tax laws, unemployment and workers' compensation laws, employment and discrimination laws, disability laws, environmental laws, and product labeling laws, and (iii) federal, state, and local building and zoning codes. The details of federal, state, and local laws and regulations vary from place to place, and you must make sure that you are familiar with these laws and that you comply with them

We also offer to certain qualified candidates, at our discretion, the right to develop and operate multiple units A "qualified candidate" for an Area Development Franchise must have a minimum net worth of \$1,000,000, with liquid capital of no less than \$400,000, plus restaurant



Kitchen Equipment

You are required to buy certain kitchen equipment from our affiliate or us before opening your store, including noodle cookers, table top refrigerators, stock pot warmers, drop in food warmers, sandwich prep refrigerators, countertop convection ovens, stock pot ranges, hot water dispensers noodle wash drop in sinks 6 burner range and ovens charbroilers, double deep fryers, coffee makers, ice makers, soda machines refrigerators, treezers food processors ice tea dispensers charbroiler grills, griddles gas fryers meat slicers 4 burner gas ranges.
