As a franchisee, you will operate a swimming pool and spa construction and remodeling business under the name California Pools®. The California Pools brand was founded in 1952. With more than seven decades of experience, including the construction of more than 70,000 pools, the California Pools brand has earned a reputation as one of the largest and most-respected pool and spa builders. California Pools has won local, national and international design and construction awards and is featured on HGTV/DIY Network's Pool Kings television program.

The total investment necessary to begin operations of a California Pools franchise ranges from \$8,000 to \$90,000. This includes \$0, \$10,000 or \$20,000 that must be paid to the franchisor or affiliate, depending on whether the franchisee is converting from our affiliate's license or agency agreement, from another brand or is new to the swimming pool and spa construction and remodeling business.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale.
