The franchise offered in this disclosure document is for the rights to own and/or operate a CAMBRIA SUITES® ("CAMBRIA SUITES") hotel business ("CAMBRIA SUITES").

The total investment necessary to begin operation of a 121-room CAMBRIA SUITES hotel franchise is between \$10,961,20010.962,000 and \$14,636,55014,431,100. This includes an affiliation fee of \$500 per room, (\$60,000 minimum) for CAMBRIA SUITES; a property management system software license and systems training fee of between \$11,750 and \$15,750; and orientation, sales, and leadership training fees of between \$7,500 and 12,000 per person, all of which must be paid to the Franchisor or its affiliates. These sums do not include the cost of purchasing or leasing land or any real estate taxes.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, us or our affiliates in connection with the proposed franchise sale or grant. EXCEPT FOR CLAIMS AGAINST YOU FOR INDEMNIFICATION AND ACTIONS SEEKING TO STOP YOU FROM USING OUR MARKS IN VIOLATION OF THE FRANCHISE AGREEMENT, THE FRANCHISE AGREEMENT REQUIRES THAT ALL DISAGREEMENTS BETWEEN US BE SETTLED BY ARBITRATION. ALL ARBITRATIONS WILL BE CONDUCTED IN MARYLAND. OUT OF STATE ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO ARBITRATE WITH US IN MARYLAND THAN IN YOUR OWN STATE.

2. THE FRANCHISE AGREEMENT STATES THAT MARYLAND LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS. THIS MEANS THAT FOR EVERY DOLLAR OF LIABILITIES DUE WITHIN ONE YEAR, CHOICE HAD \$1.06 IN CURRENT ASSETS. AS OF DECEMBER 31, 2011, CHOICE HAD NET INCOME OF \$110,396,000, BUT A DEFICIT NET WORTH OF \$25,561,000548,904,000 PRIMARILY ATTRIBUTABLE TO OUR REPURCHASE OF OVER 44.8 MILLION SHARES OF TREASURY STOCK THROUGHPAYMENT OF A SPECIAL CASH DIVIDEND OF APPROXIMATELY \$600 MILLION TO SHAREHOLDERS ON AUGUST 23, 2012+.
