The franchise offered is for the operation of a full service CAMILLE'S HAND DIPPED ICE CREAM SHOP hereinafter referred to as CAMILLE'S, offering an excellent selection of high quality premium ice cream delights, including, cones, shakes, sundaes, and other products in a clean, family-oriented environment with exceptional service to its customers. The initial franchise fee is \$30,000. The estimated initial investment required ranges from \$189,125 to \$304,600 (including rental costs for your facility).
