Camp Run-A-Mutt businesses operate upscale cage-free doggie daycare and boarding facilities that feature playground activities, washing, grooming, dog obedience training, real-time online viewing capabilities and a retail center offering pet products, toys and various types of pet supplies ("Camp Run-A-Mutt Business(es)").

The total investment necessary to begin operation of a Camp Run-A-Mutt franchise ranges from \$187,725 to \$471,925, including \$45,580 to \$68,580 which must be paid to the franchisor or its affiliates.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale.
