This franchise is for the operation of a business providing in-home dog training, behavior modification and consulting services to dog owners. A Canine Dimensions business may also offer boarding, board and train, group lessons, and sales of natural dog food and other complementary products.

The total investment necessary to begin operation of a Canine Dimensions franchised business is \$45,950 to \$52,250. This includes \$39,500 that must be paid to the franchisor or its affiliate. Please see Items 5 and 7 for additional details.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully.
