As a franchisee, you will operate a business providing in-home dog training, behavior modification and consulting services to dog owners. You may also offer boarding, board and train, group lessons, and sales of natural dog food and other complementary products.

The total investment necessary to begin operation of a Canine Dimensions franchise is between \$60,950 and \$67,750. This includes \$48,500 that must be paid to the franchisor or its affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive the disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**
