FRANCHISE OFFERING CIRCULAR

As a franchisee, you will operate a business relating to the operation of Frozen Treat Centers, which serve health conscious, high-energy, natural frozen yogurt and related products to the general public.

The initial franchise fee for a start-up franchise or a conversion franchise is \$20,000 payable upfront upon execution of agreement. The estimated initial investment ranges from \$154,000 to \$241,000 for a start-up franchisee or \$146,000 to \$258,000 for a conversion franchisee.

RISK FACTORS:

- I. THE FRANCHISE AGREEMENT REQUIRES THAT MOST DISAGREEMENTS BE SUBMITTED TO ARBITRATION (OR LITIGATION, IF ARBITRATION IS NOT APPLICABLE) IN CALIFORNIA. OUT OF STATE ARBITRATION (OR LITIGATION) MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO ARBITRATE (OR LITIGATE) WITH US IN CALIFORNIA THAN IN YOUR HOME STATE. SOME STATE FRANCHISE LAWS PROVIDE THAT JURISDICTION AND VENUE PROVISIONS ARE VOID OR SUPERSEDED. YOU MIGHT WANT TO INVESTIGATE WHETHER YOU ARE PROTECTED BY A STATE FRANCHISE LAW. YOU SHOULD REVIEW THE STATE SPECIFIC ADDENDUM ATTACHED TO THIS OFFERING CIRCULAR AND FRANCHISE AGREEMENT FOR SPECIFIC PROVISIONS.
- 2. THE FRANCHISE AGREEMENT STATES THAT CALIFORNIA LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS. SOME STATE FRANCHISE LAWS PROVIDE THAT CHOICE OF LAW PROVISIONS ARE VOID OR SUPERSEDED. YOU MIGHT WANT TO INVESTIGATE WHETHER YOU ARE PROTECTED BY A STATE FRANCHISE LAW. YOU SHOULD REVIEW THE STATE SPECIFIC ADDENDUM ATTACHED TO THIS OFFERING CIRCULAR AND FRANCHISE AGREEMENT FOR SPECIFIC PROVISIONS.
- 3. THE FRANCHISOR DOES NOT OPERATE A BUSINESS OF THE TYPE BEING FRANCHISED AND RECENTLY BEGAN OFFERING FRANCHISES. YOU MAY WANT TO CONSIDER THIS IN DECIDING WHETHER TO PURCHASE A FRANCHISE.
- 4. BY NOT HAVING A PRINCIPAL REGISTER FEDERAL REGISTRATION FOR "CANTALOOP," WE DO NOT HAVE CERTAIN PRESUMPTIVE LEGAL RIGHTS GRANTED BY A REGISTRATION.
 - 5. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
