The franchise offered is for a full-service restaurant featuring a Modern Mexican style menu and full bar services to be operated under the name Cantina Laredo. We franchise agreements for the right to establish a single restaurant at a specified location.

The total investment necessary to begin operation of a Cantina Laredo restaurant is \$2,110,000 to \$3,565,000 per restaurant. This includes \$50,000 that must be paid to the franchisor or affiliate as an initial fee and an estimated \$750,000 to \$1,000,000 in recommended equipment and inventory purchases that may be made from the franchisor or an affiliate.

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, Cantina Laredo Restaurants, L.L.C. or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this Disclosure Document.**

OUT-OF-STATE ARBITRATION OR LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT OF DISPUTES. IT MAY ALSO COST YOU MORE TO ARBITRATE OR LITIGATE WITH US DALLAS, TEXAS THAN IN YOUR OWN STATE.
2. THE FRANCHISE AGREEMENT STATES THAT TEXAS LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
