The franchisee will offer the Cardio Barre fitness program at a single business location. The initial franchise fee is \$35,000. The estimated investment necessary to begin operation of a Cardio Barre franchise ranges from \$146,613 to \$211,613. This includes \$35,000 that is paid to Cardio Barre Franchise, LLC and \$4,663 that is paid to its affiliates.
