With this Franchise Disclosure Document ("Disclosure Document"), CareBuilders At Home, Inc. is offering a franchise to use certain designated trademarks, proprietary products and services, sales and marketing techniques, and methods of operation. The franchise is to operate a "CareBuilders At Home" Franchised Business that provides non-medical in-home care services, including companionship, meal preparation, light housekeeping, grocery shopping and other forms of incidental transportation, grooming and assistance with recreational activities, personal care services related to core activities of daily living, such as eating, bathing, walking, and dressing and ancillary services including in-home emergency monitoring and medication management systems as well as assisted living guidance and senior placement services.

The total investment necessary to begin operation of a CareBuilders At Home franchise is \$68,750 to \$98,500. This includes \$39,500 that must be paid to the franchisor and/or its affiliate.

We also offer to qualified individuals and entities the opportunity to become our Development Agent within a specific geographical area. A Development Agent will act as our agent in a specific territory, solicit new franchisees, assist existing franchisees, and conduct inspections of franchises in the territory, among other things. A Development Agent must pay us an initial fee that will depend on the number of CareBuilders At Home franchises to be developed. A Development Agent must also own and operate at least one CareBuilders At Home business in the Development Area. We will pay a Development Agent a portion of certain fees collected from franchisees in its Development Area.

This disclosure document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive the disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale.
