CarePatrol Franchise Systems, LLC offers franchises for the operation of a business that provides assisted living senior referral and placement services as well as information and marketing services to families looking for assisted living, in-home care, and other senior related services.

The total investment necessary to begin operation of a CarePatrol franchise ranges from \$64,400 to \$82,450. This includes \$56,730 that must be paid to us or our affiliates.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**
