CarePatrol Franchise Systems, LLC offers franchises for the operation of a business that provides assisted living senior referral and placement services as well as information and marketing services to families looking for assisted living, in-home care, and other senior related services.

The total investment necessary to begin operation of a CarePatrol franchise ranges from \$64,649 to \$82,699. This includes \$57,099 that must be paid to us or our affiliates.
