The total investment necessary to begin operation of a Caring Senior Service franchise is \$58,585 to \$107,450 This includes \$35,000 that must be paid to the franchisor and/or its affiliate, as appropriate We may finance up to \$15,000 of the initial franchise fee Please see Items 5, 7, and 10 for additional details

We also offer an Options Agreement to allow for the option to purchase additional territories If you sign the Options Agreement, you will pay a fee equal to \$7,500 for each option on additional territory you purchase, up to a maximum of two options This amount will be applied toward the reduced initial franchise fee payable for each additional territory under the Options Agreement Please see Items 5 and 7 for additional details
