
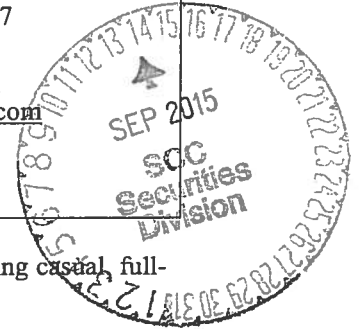

The franchise offered is to develop and operate Carrabba's Italian Grill® restaurants offering casual, full-service dining.

The total investment necessary to begin operation of a Carrabba's Italian Grill restaurant ranges from \$2,575,700 to \$6,192,000. This includes \$170,500 to \$230,000 that must be paid to the franchisor or its affiliates.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
