

You operate an automobile collision repair facility identified by distinctive trademarks and service marks including the name CARSTAR[®], and utilizing a system of regional marketing, preferred vendor relationships, business and financial analysis, providing services to the insurance industry, to commercial accounts and to individual automobile owners

The total investment necessary to begin operation of a conversion CARSTAR franchise is \$6,218 to \$102,495, which includes an initial fee of \$2,500 to \$14,995 that must be paid to the Franchisor The total investment necessary to begin operation of a new (ground-up) CARSTAR franchise is \$293,913 to \$798,995, which includes an initial fee of \$2,500 to \$14,995 that must be paid to the franchisor


