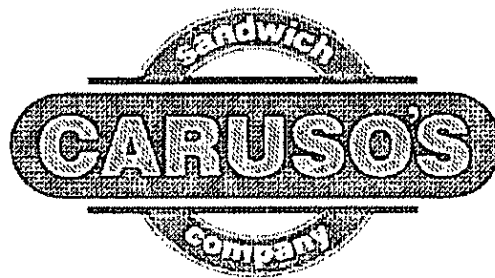

The total investment necessary to begin operation of a Caruso's Sandwich Company franchise is from \$111,100.00 to \$249,500.00. This includes \$30,000.00 that must be paid to the Franchisor or affiliate.
