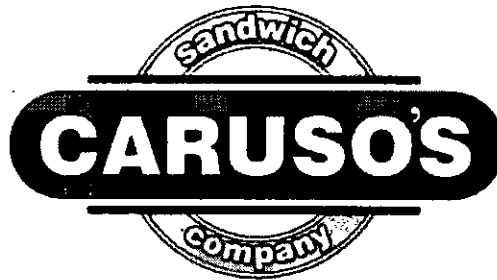

The total investment necessary to begin operation of a Caruso's Sandwich Company franchise is from **\$131,100.00 - \$287,500.00**. This includes \$30,000.00 that must be paid to the Franchisor or affiliate.
