The franchise offered is for a contemporary dessert store that serves made-to-order ice cream flavors and creations using high-quality, all-natural ingredients. The franchise operates under the name “Cauldron Ice Cream” and offers dine-in and take-out service.

The total investment necessary to begin operation of a Cauldron Ice Cream franchise is \$269,100 to \$533,500. This includes \$50,000 to \$69,000 that must be paid to the franchisor and/or its affiliates.

If you enter into a Multi-Unit Operator Agreement to develop at multiple Cauldron Ice Cream franchises, when you sign the Multi-Unit Operator Agreement you will pay a development fee equal to 100% of the initial franchise fee for the first store to be developed, plus a deposit of 50% of the initial franchise fee for each additional store to be developed under the Multi-Unit Operator Agreement. You are required to develop a minimum of three stores to enter into a Multi-Unit Operator Agreement. The total estimated investment under a Multi-Unit Operator Agreement to develop three Cauldron Ice Cream Franchises is \$321,100 to \$586,000. This includes \$80,000 that must be paid to the franchisor and/or its affiliates. The total investment under a Multi-Unit Operator Agreement will vary depending on the number of stores to be developed.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive the disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**
