The franchised business is to operate a soul food restaurant focused on southern-inspired entrees and inspiring hope, unity and love, under the trade name "Celebrity's Soul Food"

The total investment necessary to begin operation of a Celebrity's Soul Food franchise is \$245,025 to \$640,375. This includes \$35,000 that must be paid to the franchisor or affiliate. The total investment necessary to begin operation under a three- to five-unit Multi-Unit Development Agreement is \$296,025 to \$745,375. This includes \$50,000 to \$100,000 that must be paid to the franchisor. There is no minimum number of Celebrity's Soul Food units that you are required to develop under the Multi-Unit Development Agreement.
