We offer a franchise to operate cell phone repair businesses within specified geographic areas using the "CPR" marks that provide repair services we authorize for smart phones, cell phones, laptops, game systems and other electronic devices. We offer a territory based on the size and demographics of the market the franchise(s) are located in. We offer franchises individually under the terms of a standard franchise agreement.

The total investment required to establish a Cell Phone Repair Business ranges from \$55,650 to \$170,500. This includes \$26,833 to \$64,500 which is payable to us or our affiliates.
