Enclosed for filing are two franchise renewal applications, submitted on behalf of CHS Inc. d/b/a Cenex (the "Company"), renewing its motor vehicle franchise registrations under Minnesota regulation 2860.5200.

Pursuant to the requirements of Minnesota regulations, Section 2860.5200 and 2860.5300, we have enclosed the following with respect to each of these registrations:
