The franchise described in this Disclosure Document is to operate a "Championship Martial Arts" business, which is a Martial Arts Center offering core martial arts, weapons training, performance martial arts, cage fitness, and self defense. Championship Martial Arts offers a world class curriculum developed by some of the best martial artists in the world.

The total investment necessary to begin operation of a Championship Martial Arts franchise is \$61,600 to \$150,111. This includes between \$25,000 and \$75,000 that must be paid to the franchisor and/or its affiliate, as appropriate.

We also offer a Multi-Unit Development Agreement for the development of multiple centers. If you sign the Multi-Unit Development Agreement, you will pay a development fee equal to \$2,500 for each center to be developed. The total investment under a Multi-Unit Development Agreement will vary depending on the number of centers to be developed.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive the disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**
