The franchise offered is for the operation of a delivery/takeout pizza restaurant. The total investment necessary to begin operating a Chanticlear Pizza® restaurant, including initial working capital, is estimated at between \$164,000 and \$235,000. This includes a \$15,000 initial franchise fee that must be paid to us.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
