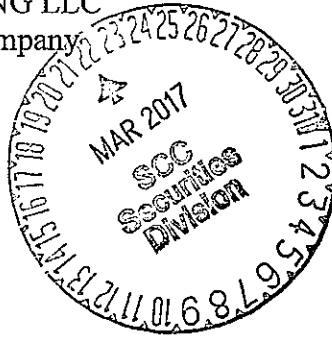

You will sell fast, casual fare featuring charcoal pit cooked meats, BBQ and fish, in a variety of sandwiches and platters, other related products, and may sell beer and wine, from a CHAPS PIT BEEF® restaurant.

The total investment necessary to begin operation of a CHAPS PIT BEEF® franchised business is \$332,800 to \$782,000, or if you offer beer and wine, \$353,100 to \$1,817,000. This includes \$25,000 to \$29,000 that must be paid to the franchisor or its affiliate(s).

We also offer a multi-unit development opportunity. The total investment necessary under the multi-unit development agreement for development of a minimum of three CHAPS PIT BEEF® restaurants is \$42,500. This includes \$42,500 that must be paid to the franchisor or affiliate. There is a development fee that must be paid to us of \$25,000 for the first restaurant plus \$8,750 multiplied by the number of additional CHAPS PIT BEEF® restaurants that you must open under the multi-unit development agreement, after the first. We will credit the development fee paid for a particular restaurant as a deposit against the initial franchise fee for the restaurant.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

Your state may have a franchise law that requires a franchisor to register or file with a state franchise administrator before offering or selling in your state. YOU MAY HAVE TO SIGN A NEW AGREEMENT WITH DIFFERENT TERMS AND CONDITIONS IN ORDER TO CONTINUE TO OPERATE YOUR BUSINESS. BEFORE YOU BUY, CONSIDER WHAT RIGHTS YOU HAVE TO RENEW YOUR FRANCHISE, IF ANY, AND WHAT TERMS YOU MIGHT HAVE TO ACCEPT IN ORDER TO RENEW.

Please consider the following RISK FACTORS before you buy this franchise:

1. THE FRANCHISE AGREEMENT AND THE MULTI-UNIT DEVELOPMENT AGREEMENT REQUIRE YOU TO RESOLVE DISPUTES WITH US BY MEDIATION AND ARBITRATION ONLY IN MARYLAND. OUT-OF-STATE MEDIATION AND ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO MEDIATE AND ARBITRATE WITH US IN MARYLAND THAN IN YOUR OWN STATE.
2. THE FRANCHISE AGREEMENT AND THE MULTI-UNIT DEVELOPMENT AGREEMENT STATE THAT MARYLAND LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
3. THE FRANCHISOR IS AT AN EARLY STAGE OF DEVELOPMENT AND HAS A LIMITED OPERATING HISTORY. THIS FRANCHISE IS LIKELY TO BE A RISKIER INVESTMENT THAN A FRANCHISE IN A SYSTEM WITH A LONGER OPERATING HISTORY.
4. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.

We use the services of one or more FRANCHISE BROKERS or referral sources to assist us in selling our franchise. A franchise broker or referral source represents us, not you. We pay this person a fee for selling our franchise or referring you to us. You should be sure to do your own investigation of the franchise.
