The franchise offered is to operate a Checkers Restaurant or Rally's Restaurant Fusiness Oversight menu of hamburgers, cheeseburgers, hot dogs and other menu items

The total investment necessary to begin operation of a Checkers Restaurant or Rally's Restaurant (excluding real estate and related costs) is \$637,392 to \$1,306,345 for a single drive thru freestanding restaurant, \$165,796 to \$1,096,567 for a conversion of a free standing restaurant, \$166,900 to \$850,840 for an end cap strip center restaurant, and \$318,885 to \$623,285 for an in line restaurant in a high density market This includes \$10,000 to \$50,000 that must be paid to the franchisor or an affiliate, plus \$10,000 for each additional restaurant that you agree to develop under a development agreement with us
