The Franchise offered is a ChemStation International Franchise for the sale of industrial cleansers in bulk amounts.

The total investment necessary to begin operation of a ChemStation franchise is approximately \$270,450 to \$368,450. This includes an estimated amount of about \$155,450 (covering the initial franchise fee and the price of certain equipment and inventory) that must be paid to the franchisor or an affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

1. THE FRANCHISE AGREEMENT REQUIRES YOU TO RESOLVE DISPUTES WITH US BY ARBITRATION ONLY IN OHIO. OUT-OF-STATE ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO ARBITRATE WITH US IN OHIO THAN IN YOUR OWN STATE.

2. THE FRANCHISE AGREEMENT STATES THAT OHIO LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.

3. YOU MUST ACHIEVE MINIMUM ANNUAL REVENUES AND PAY US MINIMUM ANNUAL ROYALTIES OR, IN OUR DISCRETION, WE MAY TERMINATE YOUR FRANCHISE OR MAKE YOUR TERRITORY NON-EXCLUSIVE. THE STANDARD MINIMUM ANNUAL REVENUES IS \$200,000. THE STANDARD MINIMUM ANNUAL ROYALTIES IS \$8,000.

THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.

We use the services of one or more FRANCHISE BROKERS or referral sources to assist us in selling our franchise. A franchise broker or referral source represents us, not you. We pay this person a fee for selling our franchise or referring you to us. You should be sure to do your own investigation of the franchise.
