The total investment necessary to begin operation of a CHESTER'S® Restaurant franchise within a convenience store or other retail business (other than a supermarket) or at a food court, strip mall, or other non-traditional location (such as a sports arena or stadium) is \$~~23,786~~21,872 to \$~~303,057~~293,789. This includes up to \$~~65,057~~55,789 that must be paid to the franchisor or affiliate. The total investment necessary to begin operation of a CHESTER'S® Restaurant franchise within a supermarket is \$~~21,149~~14,351 to \$~~277,979~~252,448. This includes up to \$~~43,979~~18,448 that must be paid to the franchisor or affiliate.
