Chez Nails is a beauty salon providing personalized body and nail care services and retail sales of body and nail care products

The total investment necessary to begin operation of a Chez Nails franchise ("Unit Franchise" or "Chez Nails Salon") is from **\$184,000 to \$456,500**. This includes a \$25,000 initial franchise fee that must be paid to us.

We may sell rights to develop a number of Chez Nails Salons within a specific area. The development fee equal to 100% of the initial franchise fee for the first Chez Nails Salon to be developed, plus a 50% deposit of the initial franchise fee for each additional Chez Nails Salon to be developed under the Multi-Unit Agreement. The total investment necessary will vary based on the number of Salons to be developed.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**
