You will operate a high quality childcare center and developmental learning school ("School") that provides affordable childcare and educational opportunities for children ranging in age from six weeks to 12 years old.

The total investment necessary to begin operation of a Children's Lighthouse School franchise is as follows: (1) for a leased School, the estimated initial investment ranges from \$722,500 - \$1,034,000, which includes \$100,000 to be paid to the franchisor or affiliate, or (2) for an owned School, the estimated initial investment ranges from \$3,223,500 - \$4,998,365, which includes \$100,000 to be paid to us or our affiliate(s).

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you can sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**

Please consider the following risk factors before you buy this franchise:

1. The Franchise Agreement requires you to resolve disputes with us by mediation and/or arbitration in the then-current city of our principal business office, which is currently Fort Worth, Texas. Out-of-state mediation and/or arbitration may force you to accept a less favorable settlement for disputes. It may also cost you more to mediate and/or arbitrate with us in a state other than in your own state.
2. The Franchise Agreement states that Texas law governs the agreement, and this law may not provide the same protections and benefits as local law. You may want to compare these laws.
3. The territory rights provided under the Franchise Agreement are not exclusive.
4. There may be other risks concerning this franchise.

We use the services of one or more franchise brokers or referral sources to assist us in selling our franchise. A franchise broker or referral source represents us, not you. We pay this person a fee for selling our franchise or referring you to us. You should be sure to do your own investigation of the franchise.
