The franchise offered is for the establishment and operation of a music academy providing young children, between the ages of 3 and 9, the opportunity to love and appreciate music while developing fundamental musical skills in a classroom setting for children and their parents in a fun, positive, creative and non-pressured environment

Franchises can be established in 2 ways as a standard unit or a small market unit. The total investment necessary to begin operations of a Children's Music Academy standard unit franchise is \$67,170 to \$109,600. This includes a \$32,000 franchise fee that must be paid to the franchisor or affiliate. The total investment necessary to begin operations of a Children's Music Academy small market unit franchise is \$21,570 to \$51,400. This includes a \$3,000 to \$12,000 franchise fee that must be paid to the franchisor or affiliate.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
