Children's Orchard, LLC offers individual franchises for the operation of Children's Orchard® stores ("Stores"), buying from and selling to the retail consumer clothing, equipment, accessories and toys for kids.

If you purchase certain key items used in your Children's Orchard® store, the total investment necessary to begin operation of a Children's Orchard® store is from \$214,500 to \$326,000. This includes \$33,500 to \$38,500 that must be paid to us or our affiliates. If you lease the same key items used in your Children's Orchard® store, the total investment necessary to begin operation of a Children's Orchard® store is from \$174,700 to \$275,500. This includes \$23,000 to \$28,000 that must be paid to us or our affiliates.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no government agency has verified the information contained in this document.

- 1. THE FRANCHISE AGREEMENT REQUIRES YOU TO RESOLVE DISPUTES WITH US BY ARBITRATION ONLY IN MINNESOTA. OUT-OF-STATE ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST MORE TO ARBITRATE WITH US IN MINNESOTA THAN IN YOUR OWN STATE.
- 2. AS PER THE AUDITED BALANCE SHEET DATED DECEMBER 31, 2018, THE FRANCHISOR'S GUARANTOR HAD A WORKING CAPITAL DEFICIENCY OF (\$110,610).
- 3. YOUR SPOUSE MUST ALSO SIGN A PERSONAL GUARANTEE MAKING YOUR SPOUSE INDIVIDUALLY LIABLE FOR YOUR FINANCIAL OBLIGATIONS UNDER THE AGREEMENT. THE GUARANTEE WILL PLACE YOUR SPOUSE'S MARITAL AND PERSONAL ASSETS AT RISK IF YOUR FRANCHISE FAILS.
- 4. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
