The total investment necessary to begin operation of a Chillers Microcreamy franchise is \$298,000 - \$473,500 (Land not included). Leasehold improvement is one of the varying factors. Purchasing property and building from ground up increases the investment necessary to begin operation to \$560,500 - \$1,167,500. Both included \$22,500 that must be paid to the franchisor due at signing.
