<u>Single Restaurant Program</u> Under the Single Restaurant Program, you will sign a Franchise Agreement to operate a single Chronic Tacos[®] restaurant The total investment necessary to begin operations of a single Chronic Tacos[®] restaurant ranges from approximately \$309,000 to \$538<u>658,000</u> This includes \$40,000 that must be paid to the franchisor or an affiliate

<u>Area Development Program</u> Under the Area Development Program, we assign a defined area within which you must develop and operate a minimum of 2 Chronic Tacos® Restaurants within a specified period of time. The total investment necessary to begin operations of 2 Chronic Tacos® restaurants under an Area Development Agreement ranges from approximately \$314304,000 to \$534663,000 per Chronic Tacos® restaurant. This includes an amount ranging from \$25,000 and \$35,000 that must be paid to the franchisor or an affiliate
