As a franchisee, you will operate carts, kiosks, trailers, and/or certain other equipment that we authorize offering freshly squeezed lemonade, freshly squeezed fruit juices, smoothies, cotton candy, sno cones, and other items we authorize using the name “Lemon Heaven” and/or mini donuts, coffee, hot chocolate, iced coffee, tea and other items we authorize using the name “Cin City Donuts”.

The total investment necessary to begin operation of a Lemon Heaven Business ranges from \$29,750 to \$174,000 (not including Event Fees/Rent). This includes \$11,000 to \$36,000 that must be paid to the franchisor or its affiliate(s). The total investment necessary to begin operation of a Cin City Donuts Business ranges from \$84,500 to \$216,250 (not including Event Fees/Rent). This includes \$5,000 to \$35,000 that must be paid to the franchisor or its affiliate(s). The high-end estimates for a Cin City Donuts Business include the joint operation of a Lemon Heaven Business.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**

OUT OF STATE ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO ARBITRATE WITH US IN DELTA, BRITISH COLUMBIA, CANADA THAN IN YOUR OWN STATE.**

2. **YOU WILL NOT RECEIVE AN EXCLUSIVE TERRITORY. YOU MAY FACE COMPETITION FROM OTHER FRANCHISEES, FROM OUTLETS THAT WE OWN, OR FROM OTHER CHANNELS OF DISTRIBUTION OR COMPETITIVE BRANDS THAT WE CONTROL.**

3. **IF YOU ARE NOT AN INDIVIDUAL, YOUR OWNERS WILL HAVE TO GUARANTEE YOUR OBLIGATIONS AND BE BOUND BY THE PROVISIONS OF THE FRANCHISE AGREEMENT. YOUR SPOUSE AND, IF YOU ARE NOT AN INDIVIDUAL, THE SPOUSES OF YOUR OWNERS, MUST ALSO SIGN A GUARANTY, WHICH PLACES THE SPOUSE'S MARITAL ASSETS AT RISK IF YOUR FRANCHISE FAILS.**

4. **THE FRANCHISOR HAS LIMITED FINANCIAL RESOURCES, WHICH MIGHT NOT BE ADEQUATE TO FUND THE FRANCHISOR'S PRE-OPENING OBLIGATIONS TO EACH FRANCHISEE AND PAY OPERATING EXPENSES.**
