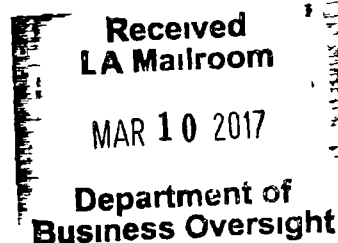

This franchise is for the operation of a membership-based facility that offers fitness kickboxing classes, including our proprietary 10-week program

The total investment necessary to begin operation of a CKO Kickboxing franchised business is \$112,997 to \$378,447. This includes \$30,000 that must be paid to the franchisor.

We may offer area development rights to establish and operate a certain number of Facilities at specific locations pursuant to individual franchise agreements. The area development fee will be equal to the total of \$30,000 for the first Facility plus 65% of the initial franchise fee (\$19,500) for each additional Facility to be developed (which means that the area development fee will vary depending on the number of Facilities to be developed). The balance of the initial franchise fee for each Facility to be developed after the first is payable when the Franchise Agreement for that Facility is signed. If you choose to develop 2 franchised businesses, the estimated initial investment is \$132,497 to \$397,947. This includes \$49,500 that must be paid to the franchisor.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive the disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**
