



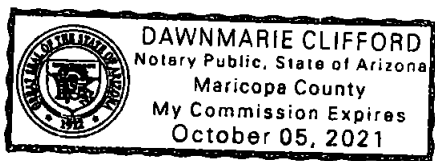

Dear Mr. Becker:

The initial franchise registration application for the above-referenced applicant has been examined. Please correct or otherwise address the following deficiencies:

1.  FTC Cover Page: the total amount to be paid to the franchisor or its affiliates does not agree with the disclosure made in Item 5.
2.  Item 2: please revise the disclosures to reflect the beginning date for the positions with the franchisor. The disclosure for Jacqueline Wallace, for instance, states "Ms. Wallace has been our Chief Financial Officer since our formation in October 2016." The franchisor was formed in 2019.
3.  Items 5 & 6: there is a discrepancy in the Technology Set-up Fee disclosed.
4.  Item 11 states, "The estimated cost to purchase required hardware and software for operation of your CLOVR Life Spa is \$22,250 to \$28,000", which is inconsistent with the disclosure made in Item 8.
5.  Item 11: please revise the disclosure provided for the director of training. It states that he joined the franchisor in 2017 while the franchisor was formed in 2019.
6.  Item 13: please state whether the trademarks "Sirius Day Spa" and "CLOVR Life Spa" are registered on the Principal or Supplemental Register of the United States Patent and Trademark Office. For each trademark, state the date and identification number.
7.  Item 13: for the parent's trademark that is not registered in the Principal Register of the U.S. Patent and Trademark Office, disclose the following statement as written:

"We do not have a federal registration for our principal trademark. Therefore, our trademark does not have many legal benefits and rights as a federally-registered
