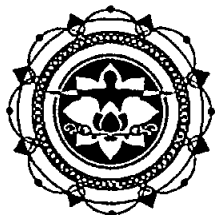

Club Pilates Global, Inc. (“we,” “us,” or “our”) offers for sale a franchise to establish and operate a fitness studio that provides low cost affordable Pilates and other exercise classes under the “CLUB PILATES” marks.

The total estimated investment necessary to begin operations of a CLUB PILATES Studio franchise ranges from \$52,250 to \$206,065. This amount includes \$14,600 to \$29,850 that must be paid to the franchisor or its affiliate. The total estimated investment necessary to begin operations of a CLUB PILATES Half-Size Studio franchise ranges from \$28,750 to \$75,625. This amount includes \$8,600 to \$17,350 that must be paid to the franchisor or its affiliate. The total investment necessary to begin operation of a CLUB PILATES Studio franchise pursuant to a multi-unit development agreement is \$104,750 to \$241,065. This includes \$67,100 - \$69,850 that must be paid to the franchisor or its affiliate. The range of expenses and the initial investment will differ based on the location you choose, the square footage of the location and amenities, whether you are converting an existing fitness facility to a CLUB PILATES Studio, and the types of equipment, furnishings, and fixtures that you purchase.

We also award to qualified applicants, under a development agent agreement, the right to assist us in the development of a specific territory, including, but not limited to, identifying and compiling information on proposed franchised businesses, lease assistance, marketing and advertising, training and on-going support to CLUB PILATES Franchisees located in a particular geographic area. When a Development Agent Agreement is signed, the Development Agent must pay us a Development Fee in the amount of \$100,000 for a minimum initial territory with a population of one million people. The estimated initial investment required to establish a Development Agent territory ranges from approximately \$108,050 to \$141,625.

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read the disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payments to the Franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**

The terms of your contract will govern your franchise relationship. Don’t rely on the disclosure document alone to understand your contract. Read all of your contract carefully. Show your contract and this disclosure document to an advisor, like a lawyer or accountant.

MANY FRANCHISE AGREEMENTS DO NOT ALLOW YOU TO RENEW UNCONDITIONALLY AFTER THE INITIAL TERM EXPIRES. YOU MAY HAVE TO SIGN A NEW AGREEMENT WITH DIFFERENT TERMS AND CONDITIONS IN ORDER TO CONTINUE TO OPERATE YOUR BUSINESS. BEFORE YOU BUY, CONSIDER WHAT RIGHTS YOU HAVE TO RENEW YOUR FRANCHISE, IF ANY, AND WHAT TERMS YOU MIGHT HAVE TO ACCEPT IN ORDER TO RENEW.

Please consider the following RISK FACTORS before you buy this franchise:

1. THE FRANCHISE AGREEMENT, MULTI-UNIT DEVELOPMENT AGREEMENT, AND DEVELOPMENT AGENT AGREEMENT CONTAIN A MANDATORY BINDING ARBITRATION CLAUSE GOVERNING NEARLY ALL DISPUTES BETWEEN YOU AND US. THE BINDING ARBITRATION (AND ANY LITIGATION) AND ANY ARBITRATION APPEAL WILL TAKE PLACE IN THE COUNTY IN WHICH OUR THEN-CURRENT HEADQUARTERS IS LOCATED, AND THAT MAY COST YOU MORE (AND BE LESS CONVENIENT) THAN IF THOSE PROCEEDINGS TOOK PLACE NEAR YOUR RESIDENCE OR BUSINESS. COSTS OF THE ARBITRATION AND ANY ARBITRATION APPEAL MAY BE GREATER THAN IN LITIGATION. YOU AND WE WILL GENERALLY BEAR EACH OF OUR OWN COSTS IN ANY DISPUTE, BUT THE ARBITRATOR CAN ASSESS COSTS (BUT NOT ATTORNEY'S FEES) AGAINST A LOSING PARTY.
2. THE FRANCHISE AGREEMENT, MULTI-UNIT DEVELOPMENT AGREEMENT, AND DEVELOPMENT AGENT AGREEMENT PROVIDE THAT THE LAWS OF THE STATE OF CALIFORNIA GOVERN THE AGREEMENTS AND THAT LAW MAY NOT PROVIDE YOU WITH THE SAME RIGHTS AND PROTECTIONS AS YOUR LOCAL LAW. YOU MAY WANT TO CONSULT AN ATTORNEY REGARDING COMPARISON OF THESE LAWS.
3. THE MARKET FOR FITNESS SERVICES IS HIGHLY EVOLVED, YET CONSTANTLY CHANGING. YOU WILL FACE COMPETITION FOR MEMBERS FROM OTHER PILATES STUDIOS, GYMS, PERSONAL TRAINERS, YOGA STUDIOS, BARRE-BASED STUDIOS, AND EVEN OTHER CLUB PILATES FRANCHISEES. ADDITIONALLY, YOU WILL FACE COMPETITION FROM COMPANIES, STUDIOS, GYMS AND PRODUCTS THAT MAY NOT BE IN EXISTENCE AT THE TIME YOU SIGN THIS AGREEMENT.
4. PRIOR TO YOU SIGNING THE FRANCHISE AGREEMENT, WE RESERVE THE RIGHT, IN OUR SOLE DISCRETION, TO AWARD, OR NOT AWARD, A CLUB PILATES FRANCHISE TO YOU, REGARDLESS OF THE STAGE OF THE FRANCHISE APPLICATION/SCREENING PROCESS AND COSTS EXPENDED BY YOU.
