The franchise is for the establishment and operation of a Cobblestone Inn and Suites or Cobblestone Hotel and Suites lodging facility (collectively referred to in this document as "Cobblestone Lodging Facilities".

The total investment necessary to begin operation of a Cobblestone Lodging Facility franchised business is between \$1,833,299 and \$6,108,600. This includes up to \$57,000 that must be paid to the franchisor or its affiliate(s).

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no government agency has verified the information contained in this document.

- 5. THE FRANCHISEE WILL BE REQUIRED TO MAKE AN ESTIMATED INITIAL INVESTMENT RANGING FROM \$1,833,299 AND \$6,108,600. THIS AMOUNT EXCEEDS THE FRANCHISOR'S STOCKHOLDERS EQUITY AS OF DECEMBER 31, 2013, WHICH IS \$111,174.
